- 1. I am the owner of the above mentioned animal and declare that no other person has any property interest therein.**
- 2. I relinquish any claims that I may have on this animal and agree that LittleV&Friends Animal Rescue may take any necessary steps in order to re-home this animal.**
3. I agree that any outstanding costs that I may have incurred as a result of the ownership of this animal have been finalised prior to releasing the animal to LittleV&Friends Animal Rescue and I have no claim on LittleV&Friends Animal Rescue in relation to those costs.
4. I agree to pay for a general veterinary health check examination and to provide a copy of the medical history report to LittleV&Friends Animal Rescue prior to the animal being accepted into the rehoming program.
5. I will hand over any relevant legal documentation relating to this animal.
